POZIV I INSTRUKCIJE AUTORIMA

Pozivaju se svi zainteresovani autori da dostave apstrakte, uslađene sa definisanim konferencijskim temama, te koji nisu prethodno objavljivani. Apstrakti bi trebalo da budu obimom ograničeni na najviše 400 reči, napisani na engleskom jeziku i priloženi u formatu Word dokumenta (.doc). Apstrakte je potrebno dostaviti na sledeću e-mail adresu: natasamiletic2@gmail.com.

Rok za dostavljanje apstrakata je 1. septembar 2023. godine

Autori apstrakata sa pozitivnim ishodom recenzije biće pozvani da dostave svoje radove u celini. Po pozitivnom svršetku dvostruke anonimne recenzije, radovi će biti objavljeni u zborniku radova sa konferencije „Bezbednost infrastrukturnih sistema: koncepti, regulativa, praksa“.

Autor može objaviti samo jedan rad u zborniku. Za objavljivanje rada neophodan preduslov predstavljaju dve pozitivne recenzije, uz poštovanje principa anonimnosti. Autorima čiji rad bude objavljen sleduje primerak zbornika radova. Uređivački odbor zadržava pravo da prilagodi rad u skladu sa opšteprihvaćenim standardima upotrebe engleskog jezika.

Tehničko uputstvo

Zahtevani obim rada je u rasponu od 4000 do 6000 reči, i rad mora biti napisan fontom Times New Roman, 12pts, sa razmakom 1,5 i marginama Top 2.5 cm; Bottom 2.5 cm; Left 3 cm; Right 3cm.

Rad počinje sa navođenjem prezimena i imena autora u gornjem levom uglu (Times New Roman 12pts). U fusnoti je potrebno navesti afilijaciju i kontakt podatke za svakog od autora (Times New Roman 10pts).

Naslov rada je potrebno napisati velikim slovima, podebljano, centrirano (Times New Roman 14 pts).

Pre glavnog dela rada, potrebno je napisati kratki apstrakt (sažetak) dužine do 8 redova, uz navođenje do 5 ključnih reči (Times New Roman 10pts). Apstrakt treba da sadrži informacije o cilju rada, primenjenim metodama, rezultatima i izvedenim zaključcima.

Glavni deo rada treba da sadrži uvod, podnaslove i zaključak. Podnaslove je potrebno pisati centrirano, podebljano, malim slovima i numerisati ih. Naslove trećeg reda treba pisati malim slovima, iskošeno, uz numeraciju. Glavni tekst treba pisati fontom Times New Roman 12pts, sa razmakom 1,5. Nakon zaključka, potrebno je navesti spisak korišćenih referenci. U spisku referenci potrebno je navesti sve izvore korišćene u radu, odnosno samo one izvore u radu jasno istaknute.

In the reference list, include the page range for the chapter or part. In the text, cite specific pages.

E-book

For books consulted online, include a URL or the name of the database in the reference list entry. For other types of e-books, name the format. If no fixed page numbers are available, cite a section title or a chapter or other number in the text, if any (or simply omit).

Journal article

In the reference list, include the page range for the whole article. In the text, cite specific page numbers. For articles consulted online, include a URL or the name of the database in the reference list entry. Many journal articles list a DOI (Digital Object Identifier). A DOI forms a permanent URL that begins <https://doi.org/>. This URL is preferable to the URL that appears in your browser's address bar.

Journal articles often list many authors, especially in the sciences. If there are four or more authors, list up to ten in the reference list; in the text, list only the first, followed by *et al.* ("and others"). For more than ten authors (not shown here), list the first seven in the reference list, followed by *et al.*

News or magazine article

Articles from newspapers or news sites, magazines, blogs, and the like are cited similarly. In the reference list, it can be helpful to repeat the year with sources that are cited also by month and day. Page numbers, if any, can be cited in the text but are omitted from a reference list entry. If you consulted the article online, include a URL or the name of the database.

Website content

It is often sufficient simply to describe web pages and other website content in the text ("As of May 1, 2017, Yale's home page listed . . ."). If a more formal citation is needed, it may be styled like the examples below. For a source that does not list a date of publication or revision, use *n.d.* (for "no date") in place of the year and include an access date.

Social media content

Citations of content shared through social media can usually be limited to the text (as in the first example below). If a more formal citation is needed, a reference list entry may be appropriate. In place of a title, quote up to the first 160 characters of the post. Comments are cited in reference to the original post.

Text

Conan O'Brien's tweet was characteristically deadpan: "In honor of Earth Day, I'm recycling my tweets" (@ConanOBrien, April 22, 2015).

Personal communications, including email and text messages and direct messages sent through social media, are usually cited in the text only; they are rarely included in a reference list.
